Fantastic Facilities- How Things Have Changed


Two and a half years ago I took David Jolliffe, the Regional Director on a school tour. There were a number of buildings which we discussed with concern. The Preschool, was clearly inadequate for our needs. The old wooden transportable building affectionately known as the Purple Palace was riddled with white ants and wood rot, the roof leaked, and urgently needed a paint, both inside and out. The library was clearly inadequate with insufficient room for a whole class to sit at tables and work. We spent considerable time discussing what could be done about these facilities. This week I took David Jolliffe on another tour of the school. We visited our new Preschool, Library and double classroom building, and discussed the architectural plans for the Stephanie Alexander Kitchen Dining Room and the refurbishment of front office and PACA room. How times have changed! Thanks to a SA capital works grant, and the Economic Stimulus Package, in the next weeks and months we will move into our new buildings, and the facilities for our students will be second to none.



We still need to do our part!- Gymnasium Building Levy

Thanks to the foresight of our Governing Council and their hard work over many years, our facilities include a Gymnasium which still has that **WOW** factor! Parents, teachers, students and community, all find the gymnasium exactly right for our needs, be it for school assemblies, Footsteps Dance, Active After School Programs or the forthcoming Parents & Friends disco.

STUDENT FORUMS

Recently, some parents approached me to ask for
some information on Student Forums. Student
Forums were introduced three years ago as an
alternative to SRC. Our goal was to ensure
greater participation - all students from Year1
classes up are involved in the forums. (In
comparison, SRC involved only a small number
and it was often the same students each year.)
The Student Forums are a thriving student-led
and managed programme which involves and
benefits all. The groups are led by Year 6/7
students with assistance from an adult mentor.
Each forum has a range of students from across
the school. The groups have about 20 members
and meet most Thursdays from 10.20 to 11.00.
Staff decide on the specific forums each year. For
2010, we have 13 groups. They are:

be forum leaders. All other students were able to
rank their first 5 forum choices. Student forum
leaders call on the interests and opinions of their
group of students to decide the directions the
group will take. It is also an excellent opportunity
for students to get to know students and teachers

from other year levels, which strengthens the
community feel of the school.

Forum leaders regularly speak at whole school
assembly to advertise activities that are coming
up around the school. They also advertise by

Frequently Asked questions about the Gymnasium Building Levy.

The Building fund is voluntary, right? Yes the Governing Council has made it Voluntary. This is because they are thinking of Littlehampton families. By making it voluntary, it gains tax deductible status. Governing Councils have the option of making a building levy compulsory, (as has Heathfield High School) but by doing this we would lose tax deductible status. **Voluntary, it may be, but we rely on every family to contribute.**

200 families x \$100 = \$20,000.

But I'm a School Card holder, does this apply to me? Yes! ...but at a reduced rate. Governing Council has approved a \$70 per annum levy for school card holders. We are relying on you too!

I think the Government should pay for school buildings- Well, many people would agree, but that's not the way it works. By everyone pitching in we have a gym, while other schools, where people aren't prepared to contribute, don't. Would you really want to give up this wonderful facility for our children?

Some schools are getting gymnasiums built for them under the BER funding. Yes, they are. Because we already have a gymnasium, we are able to use the funding to build a new Library Resource Centre, a much needed facility for our school.

How are we going so far this year? So far, 38 families have paid the voluntary levy. This comes to a total of \$3945, and is just one family less than at the same time last year.

I really can't afford it... I'm having difficulty making ends meet. We are making an effort to keep costs for excursions and performances to a minimum for this year, to minimize extra costs to families. We are also happy to take payment in installments, a practice many families find helps with the family budget.

What will happen if we can't raise \$26,500 this year? The money will be deducted from our school account anyway. Our school will have to cut back on spending in areas which provide learning programs for our children, curriculum resources such as library books, computers, and maths equipment, or cut staff.

How will my donation be acknowledged?

Early in term 3 a special issue of our school newsletter will acknowledge all donations and donors. This is an important way of acknowledging what our families have put in, and celebrating how we are going.

Donations of more than \$250 will be listed on our sponsorship board in the gym.

I've donated, but I'd rather my name not be printed in the newsletter, is that ok? Yes, simply include a written note to this effect when you make your donation, and your donation will be listed anonymously.

DROUGHT RELIEF available again this year!

The school has just been informed that once again in 2010 \$10,000 will be given to the school for drought relief. In line with our policy last year, this will be used to subsidise one major whole school performance or student workshop per year. This means that families can expect to pay at least \$50 less per child for costs of excursions and performances. Gymnastics workshops, (R-5) anti bullying performance (R-7), Footsteps Dance (Yr 6/7), Maths Fun Workshop R-7 and End of Year Swimming R-7 will be funded from Drought Relief. The remainder of the money will be used for textbooks. The Finance Committee will make out a more detailed budget at the next meeting.

This should help to make donations to the Building Fund more affordable.

Australian Schools Competitions

The competitions are conducted through the University of New South Wales Educational Testing Centre, and are for Primary students from Years 3 to Year 7 in Science, Writing, Spelling, Mathematics and English. The competitions provide opportunities for students to be assessed in an external testing situation and are also used to recognise and reward achievement. Students can enter any number of competitions, however, entry fees must be lodged by the due date (see below). If your child is interested in an extra challenge, then this is a great opportunity. The dates for the competitions are:
